



MNSURE: TAX FILING STATUS CHANGE FOR ADULT CHILDREN

Tips:

- If the adult child still lives with their parents but is no longer claimed as a dependent, the parent and adult child both need to report the tax filing status change.
- To report the change, the adult child **and** the parent must attest that the child will be filing taxes independently.
- If they still live in the same household, MNSure cannot remove an adult child from an existing application.
- A tax filing status change cannot be completed until **both** parties attest to the tax filing status change.

Reporting the change:

If the assister has both the parent and adult child in the office, the changes can be reported online.

If the assister only has the adult child or parent in the office, report the change online for the individual who is in the office.

Examples:

- Adult child moves away for college.
- Adult child graduates and starts working, but still lives at home.

***Important note:** Tax returns **must** match tax filing status in the MNSure application or you may be responsible for repaying costs of medical care.*

To report MNSure changes consumers can:

Working Together for Area Seniors

Senior Linkage Line, Legal Services of Northwest MN & Community Resource Connections

This month Senior Linkage Line staff started outreach services in Bemidji after a 2-year interruption due to Covid-19. Traveling from Warren and Crookston, staff previously met with Seniors on the Bemidji Sanford Health campus. Starting this month, staff will meet with consumers at the Community Resource Connections' office located at 716 Paul Bunyan Drive NW Bemidji MN 56601 BY APPOINTMENT ONLY.

The change in meeting location is due to several factors. As the Sanford campus continues to grow, consistent meeting space and easy access meeting locations have been challenging. As well, there are advantages for Seniors working on Medicare enrollment to engage with staff of Community Resource Connections who are able to provide local resource information and assistance with public program applications.

The addition of a third agency, Legal Services of Northwest Minnesota, adds another benefit for Seniors who are struggling with legal concerns surrounding scams, family law issues, and financial vulnerabilities.
