Online Manual Account Requests:

A MNsure Navigator can now assist clients who are unable to create an account online by helping the client complete an online request for an account to be created by MNsure on their behalf! MNsure is calling it:

Online eForm Account Requests

MNsure Navigator can upload requested documents:

Did MNsure request proofs such as income or ID? Our MNsure navigators can upload these documents on your behalf. This is much faster for you than sending them to MNsure by mail!


