



HAPPY NEW YEAR

MNsure's QHP open enrollment period ended on January 15, 2023.

There are times that consumers can qualify for health insurance and enroll in plans outside of open enrollment. This is known as experiencing a **Qualifying Life Event**. Examples of qualifying life events include:

- Birth, death, or divorce within the household
- Involuntary loss of health insurance through an employer
- The loss of Medical Assistance or MNcare due to an income increase
- Moving into or out of Minnesota

Medical Assistance and MNcare, two of 3 MNsure programs, **do not have an open enrollment period**. You can apply and enroll any time throughout the year. Only the MNsure marketplace Qualified Health Plans have an enrollment period.

Minnesota's Department of Health and Human Services is preparing to start up the annual renewal process for participants enrolled in Minnesota Care and Medical Assistance. All public program renewals were halted at the start of Covid -19 in 2020, and households have maintained nonstop coverage for nearly 3 years.

IMPORTANT: Automatic renewals will end soon regardless of the status of the public health emergency.

If you or someone you know has Medical Assistance or MNcare please make sure to report a current mailing address to the county of residence (MA) or the State of MN for MNcare. Otherwise, renewals will be sent to an old address, the consumer won't receive it, and coverage will be terminated for lack of response.

Interagency Networking Meetings:
